



### **2024-2025 - Annual EEO Public File Report**

### SECTION 3: Supplemental (Non-Vacancy Specific) Recruitment Activities Undertaken

Time Period Covered: **5/22/2024 to 5/21/2025**

Stations in Employment Unit: **KBYU-TV, KBYU-FM, KUMT-FM**

Brigham Young University (“BYU”) is a religious broadcaster for purposes of the FCC’s EEO rules. BYU is closely affiliated with The Church of Jesus Christ of Latter-day Saints. Employees are required as a condition of employment to observe certain church standards, and BYU exercises a religious hiring preference. Nevertheless, BYU’s stations’ employment unit engaged in a number of non-vacancy specific recruitment initiatives during the past year, some of which are described below:

1. **Job Fair (ii)**  
The stations hosted a job fair on September 11, 2024, to promote employment opportunities and interact with potential candidates.
2. **Internship/ Work Study Programs (v)**  
The employment unit established programs designed to assist members of the community to acquire meaningful professional-level experience and skills needed for broadcast employment.
3. **Scholarship Programs (vii)**  
The stations awarded multiple scholarships to students, including part-tuition scholarships for students pursuing a degree in a field related to broadcasting and multiple employee-funded performance-based scholarships for student employees who have made a significant contribution to the stations.
4. **Training Programs (viii)**  
The stations established training programs to help students acquire skills qualifying them for higher-level positions.
5. **Mentoring Program (ix)**  
The stations mentored student employees by teaching valuable and marketable skills.
6. **Management Training (xiv)**  
The campus employment unit provided training to management-level personnel on ensuring equal employment opportunities and preventing discrimination.  
A training on sexual harassment prevention was administered to all full-time employees.
7. **Other Activities (xvi)**  
Station Tours: The stations offered extended tours of BYU’s broadcast facilities, providing information on areas of employment within broadcasting.  
Broadcast/Communications Courses: Multiple members of BYU’s station staff also taught university-level courses in the areas of broadcasting and communications, providing information on areas of employment within broadcasting.
